

EXPRESSION OF INTEREST

BACKGROUND

SundaGas Banda Unipessoal Lda (SundaGas) is a Timor-Leste oil and gas company located in Dili with its parent Company, Baron Oil Plc, being based in the United Kingdom and listed on the AIM market of the London Stock Exchange. SundaGas operates the offshore Production Sharing Contract TL-SO-19-16 in partnership with TIMOR GAP. The Production Sharing Contract area includes the Chuditch gas field, discovered in 1998.

SundaGas anticipates a campaign of offshore drilling operations, commencing in Q4 2024. The company plans to appraise the Chuditch field and to conduct a production flow test to confirm the commercial viability of potential future gas production.

Recognising the requirements under Offshore Petroleum Operations in Timor-Leste / Decree-Law No. 32/2016 / Article 159 & 160, SundaGas is seeking Expressions of Interest from reputable, capable experienced service providers for the provision of drilling and other support services as detailed below.

FIELD AND LOCATION OVERVIEW

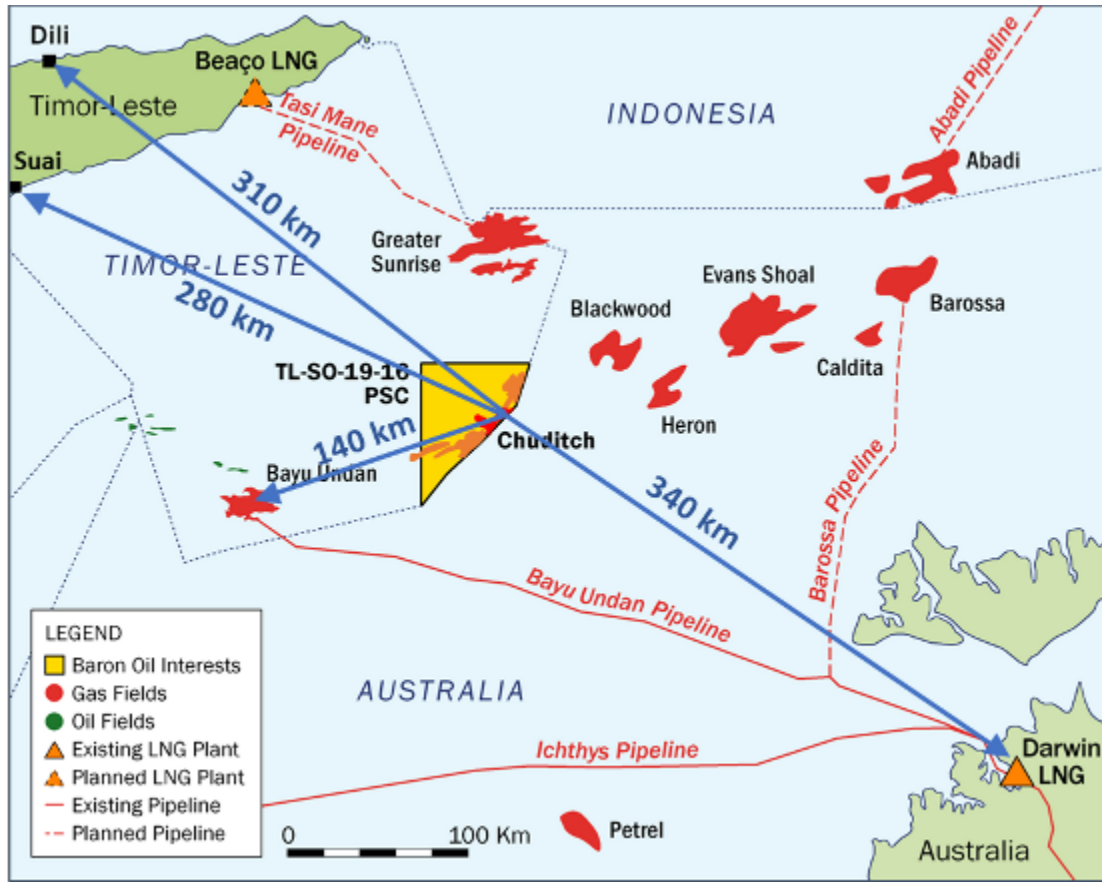
The proposed Chuditch-2 well will be located in the Timor Sea, approximately 80 km south of the Greater Sunrise gas field and 140km east-northeast of the Bayu Undan production facilities (see map). It is expected to be drilled in 60m water depths and to a target depth of around 3,000m.

The precise planned location is as follows:

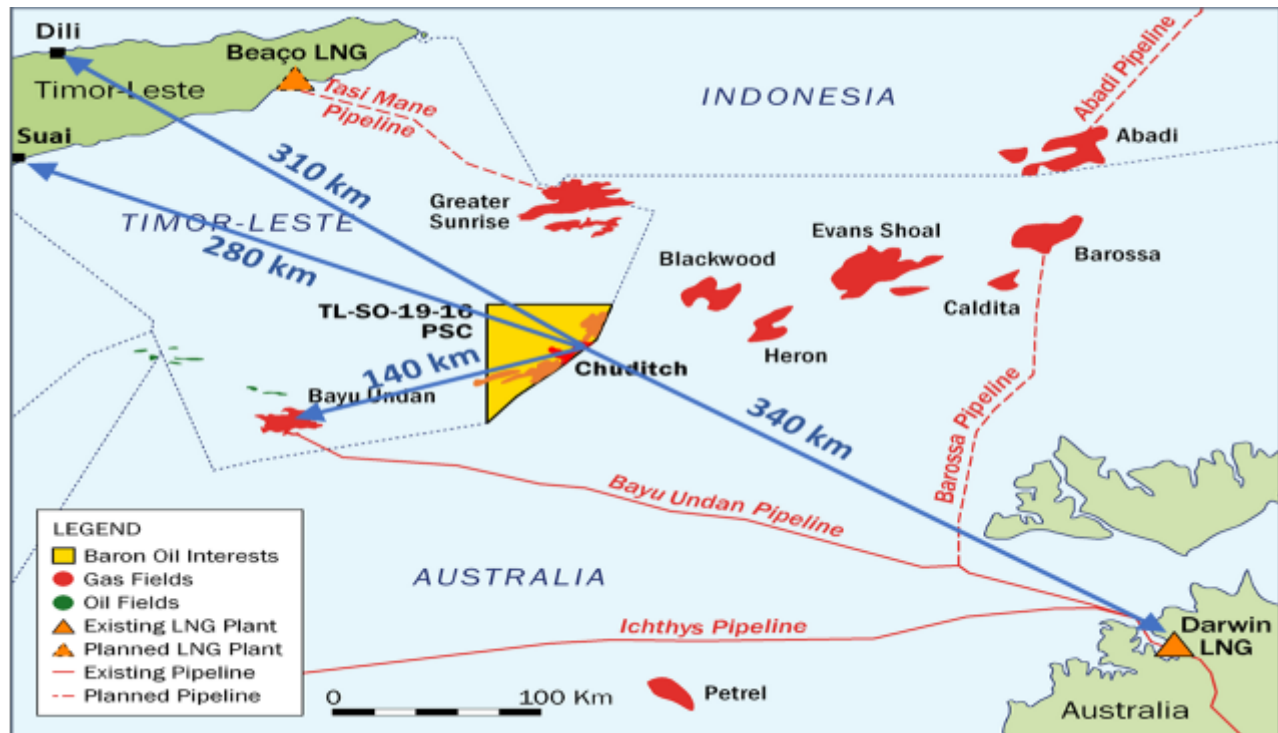
